
1. The election of Independent Director Elisa May Arboleda-Cuevas as member of the Audit and Risk Oversight Committee for the current year;

The issuance of 2,539,393,939 shares to the following Squidpay Technology Inc. shareholders and 303,030,303 shares to the following creditors, out of the increase in authorized capital stock of the Company to Php1,500,000,000.00 divided into 6,000,000,000 common shares with a par value of Php0.25 per share:

The conversion of all or a portion of the outstanding principal and capitalized interest of existing convertible loans in the amount of Php390 million, to fully paid PHA shares at an issue price of Seventy Centavos (Php 0.70) per share. The new shares will be issued out of the authorized capital stock, post-increase, in the amount of up to 557,142,857 common shares as may be finalized by the President.
